Working closely with the Release Train Senior BA, Product Owner, Scrum Master, they have responsibility for supporting the analysis approach, within the team and supporting critical assessment of activity and helping to shape and create the Product Backlog.

A core part of the role is to work closely with all other team level roles to ensure the clarity of and alignment to delivery and maintenance of features aligned Portfolio strategy and committed outcomes as set through increment planning activity. The role requires significant interaction with business stakeholders and third parties to help ensure customer and value based outcomes are captured in the product backlog of work.

Aligning to the product strategy and roadmap, with the ability to translate the stakeholder's vision of the product into the business needs and communicate it to the team members to make them understand the expectations.

To support the Practice in the continuous improvement of Business Analysis capability at the Society, helping ensure that the Practice is leading the way in collaborative, effective, straightforward, and high-quality Business Analysis.
